To Whom It May Concern:

Aramark Sports and Entertainment Services, LLC ("Aramark") was recently informed that it would not be retained to provide services at Raymond James Stadium beyond February 28, 2019. We regret to inform you that all Aramark employees assigned to that facility will be affected.

Accordingly, we are sending you this notice to satisfy the requirements of the Federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. ("WARN"). While we have not determined that WARN is applicable to this closing, we are providing this notice in the event that WARN is deemed to apply.

1. As a result of the non-renewal described above, Aramark expects to permanently terminate the employment of its employees at Raymond James Stadium as of February 28, 2019. It is our understanding that displaced employees typically have the opportunity to apply for positions with the new provider.
2. The specific job titles of our employees affected by this non-renewal, as well as the number of our employees in each job classification, are listed on the attachment to this notice.
3. There are no bumping rights applicable to these employees.
4. Our employees affected by this non-renewal are not represented by a union, but all affected employees have been notified of their separation from employment and their separation date.
