Pursuant to the Worker Adjustment and Retraining Notification Act ("WARN"), we are informing you that, between June 30 and June 30, 2020, Freeman Expositions, LLC will terminate the employment of 128 employees at its facility located at 2200 Consulate Drive, Orlando, FL 32837. This action does not involve the closing of the entire facility or of any functional areas within the facility.

This action is expected to be permanent in nature. This action is due to the unforeseeable business circumstances caused by the continuing COVID-19 pandemic and its ongoing devastating financial impact on our business. Due to the unforeseeable business circumstances arising from this national emergency, the Company was not able to provide additional notice. Instead, the Company is providing notice as soon as practicable.

1. This action is expected to occur between June 30 and June 30, 2020.

2. The number of workers who hold affected jobs in each job classification, the job titles of the affected positions, and schedule of separations are as shown on Exhibit "A" which is attached and made a part of this notice.
3. Bumping rights do not exist.
4. The impacted employees are not union members and, therefore, union representatives have not been notified.
