Re: WARN Notice

Dear Mr. Gustafson:

In connection with the COVID-19 pandemic and associated protective measures, Mears Destination Services, Inc. and City Cab Company of Orlando, LLC d/b/a/ Mears Transportation Group ("Mears" or "Company") has experienced an unforeseen change in business circumstances, which has resulted in a change in the Company's finances. As a result, we are writing to notify you that Mears will need to lay off a number of individuals employed at its location at One Airport Blvd. / 9202 Jeff Fuqua Blvd., Orlando, FL 32827. The Company does not believe that the Worker Adjustment and Retraining Notification Act ("WARN Act"), applies to this layoff; however, we are providing this notice so that affected employees can receive all possible government services and benefits.

Mears began the process of laying off affected employees on June 8, 2020, with a second phase of layoffs on July 31, 2020. Timely WARN Act Notices were provided to employees affected by these layoffs. Unfortunately, the unforeseen change in business circumstances continues to have an adverse impact on the Company's finances. Therefore, a third phase of layoffs occurred on August 31, 2020, and we have provided as much notice as possible to affected employees under the circumstances. At this time, 8 employees at this location were affected by this layoff. A list of the job classifications with the number of potentially affected employees in each job classification is attached as **Exhibit A**. No bumping rights exist, and no employees are represented by a union.
