Rexall Sundown, Inc. (the "Company") is in the process of further consolidating its supply chain network to increase efficiency. In connection with this consolidation, the Company will wind down operations at the facilities located at the above addresses over a period of several months, which will result in the termination of employment for a total of 250 employees. The first Company terminations will take effect on May 1, 2019 or during the 14 day period commencing on that date. It is anticipated that all further terminations at this facility/facilities will be completed by December 31, 2019. A chart of the expected schedule is appended.

The affected employees' respective terminations from employment with the Company will be permanent. The employees have no elected collective bargaining representative. The facilities will close once the wind down is complete.

We may be able to offer employment to some terminated employees at our facilities located in other states, although such employment is not guaranteed and no decisions about future employment have been made at this time.
