Re: Notice Pursuant to the Worker Adjustment and Retraining Notification Act

Dear Mr. Gustafson,

I am writing on behalf of Triad Digital Media, LLC (the "Company") to inform you that the Company will be ceasing operations and closing its offices located at 100 Carillon Parkway, Suite 100, St. Petersburg, Florida, 33916. This shutdown is expected to begin on April 30, 2020 and will include all titles and positions. This shutdown is expected to be permanent. We expect that individual employees will be terminated between April 30, 2020 and December 31, 2020. Please note that this timing is based on information available at this time and may change based on business circumstances. If the timing of this closing and the terminations changes, we will notify you as soon as possible. A list of the names, addresses, and job titles of the affected employees is attached hereto as **Exhibit A**.

The Company is providing you with this notice regarding this "plant closing" pursuant to the Worker Adjustment and Retraining Notification (WARN) Act. Please consider this letter to be your official notice as required under this statute. This statute also requires us to inform you that "bumping rights" (i.e., the right to take a more junior employee's job), are inapplicable in this situation and do not exist. Notices have also been provided to the Company's affected employees (by first class mail return receipt requested) and to the Mayor of St. Petersburg, Florida and the Chairperson of the Board of County Commissioners for Pinellas County. All such notices were sent on April 17, 2020. A sample of the notice sent to the affected employees is attached hereto as **Exhibit B**.

The Company was not able to give greater advance notice of this termination since this termination arises from unforeseeable business circumstances. Like many others, the Company's business has been hit hard by the sudden, dramatic, and unexpected economic impact of the COVID-19 epidemic and Florida and the federal government declaring a state of emergency. While this is out of the Company's control and we could not see this coming, like many other businesses, we unfortunately need to take immediate action under these dire circumstances. Thus, we are notifying affected employees of this plant closing as soon as practicable.

Dear Stefanie,

I am writing on behalf of Triad Digital Media, LLC (the "Company") to inform you that the Company will be ceasing operations and closing its offices located at 100 Carillon Parkway, Suite 100, St. Petersburg, Florida, 33916. This shutdown is expected to begin on April 30, 2020 and will include all titles and positions. This shutdown is expected to be permanent. We regret to inform you that as a result of this shutdown, your position will be eliminated and your employment will be terminated during the 14-day period commencing on August 13, 2020. Please note that this timing is based on information available at this time and may change based on business circumstances. If the timeframe does change, we will notify you as soon as possible.

The Company reserves the right to terminate your employment prior to August 13, 2020, and in the event that it does so, other than a termination for cause, you shall remain eligible for compensation and benefits through August 13, 2020. If you resign prior to August 13, 2020, you shall no longer be eligible for any further payments or benefits.
