Please be advised that the Department of Juvenile Justice (on very short notice) has transitioned the administration of the facility located at 5050 NE 168th St, Okeechobee, FL 34972 to Youth Opportunity Investments effective September 28, 2020. As such, TrueCore Behavioral Solutions (Company) no longer operates that facility. All Company employees are affected by this closing.

The last day of employment with TrueCore for the affected employees was September 28, 2020. However, the new provider was evaluating which employees impacted by the change to be offered positions with the Provider. It is our understanding that a majority of the employees were hired by the new Provider and that it is continuing operations at this location. Therefore, it is uncertain whether this is an event requiring notice to your agency. However, in an abundance of caution, we are notifying you of these changes.

A list of affected job titles and number of employees per classification is attached. None of the affected employees are represented by a union. The end of operations with TrueCore will be permanent, and no bumping rights will exist for employees; however, they were offered the opportunity to transfer to vacant positions at other TrueCore locations within the State of Florida and, as mentioned above, had an opportunity to be retained by the new Provider at this facility/location.
