To Whom It May Concern:

This letter will serve as official notice that a layoff impacting the hourly and salaried Food and Nutritional Services with Morrison Healthcare employees will occur at the following locations:

- Coral Gables Hospital, 3100 Douglas Rd, Coral Gables, FL 33134, impacting 17 union employees, 6 hourly non-union employees on December 15, 2024 and 2 salaried employee on December 31, 2024.
- Florida Medical Center, 5000 W Oakland Park Blvd, Lauderdale Lakes, FL 33313 impacting 28 hourly non-union employees on December 15, 2024 and 5 salaried employees on December 31, 2024.
- Hialeah Hospital, 651 E 25th St, Hialeah, FL 33013 impacting 26 hourly non-union employees on December 15, 2024 and 5 salaried employees on December 31, 2024.
- Palmetto General Hospital, 2001 W 68th St. Hialeah, FL 33016 impacting 50 hourly non-union employees on December 15, 2024 and 8 salaried employees on December 31, 2024.
- Northshore Medical Center, 1100 NW 95th St, Miami, FL 33150 impacting 23 hourly union employees and 5 non-union on December 15, 2024 and 3 salaried employees on December 31, 2024.

Notices to these impacted employees will be issued by hand and mail as of the date of this letter.

We expect this action will be permanent, and we reasonably anticipate that most employees will be hired by the hospital. The 17 impacted hourly union workers at Coral Gables are represented by SEIU Local 32BJ and the 23 impacted hourly union workers at Northshore 1199SEIU. Bumping rights are irrelevant as all persons are being laid off.
